**B. 2014 TUMF Network Discussion**

Duane Burk, City of Banning discussed his concerns with Highland Springs/Cherry Valley Boulevard on the TUMF Network as a four lane facility.

Ruthanne Taylor Berger, WRCOG Deputy Executive Director, discussed Singleton Road segments in the City of Calimesa and how it is broken up in the Network in two sections.

Michael Thornton, City of Calimesa, said that the City would like to add Roberts Road to the Network. Mrs. Taylor Berger stated that all revision requests would be considered and reminded the City that there are network criteria that need to be met before an arterial is considered for incorporated in the Network.

Mr. Thornton mentioned County Line Road and asked what the difference between a Type 2 and Type 3 interchange indicated on the list of the 2009 Pass Zone map. Mrs. Taylor Berger replied that the difference between Type 2 and Type 3 interchanges is the associated funding.

Glenn Higa, County of Riverside, said the I-10 Bypass project limits should be I-10 to Hargrave Avenue.

Mrs. Taylor Berger said another Network meeting may be needed and asked the City of Calimesa to turn in all the documentation for the city's Network revision requests by December 1, 2014.

#### **A. Fiscal Year 2014/2015 Southwest Zone 5-Year TIP Revenue Shortfall**

WRCOG staff discussed the draft Southwest Zone Transportation Improvement Program (TIP) based on the revised TIP amendment worksheets submitted by the WRCOG Public Works Directors. Mrs. Taylor Berger reported that the Pass Zone did not meet their forecast for FY 13/14. The I-10 Bypass programmed funding for FY 14/15 was delayed to FY 16/17 to develop a two out of the five-year balanced TIP Amendment.

### **Requested Action:**

1. Discuss and provide direction.

*WRCOG's Transportation Uniform Mitigation Fee (TUMF) Program is a regional fee program designed to provide transportation and transit infrastructure that mitigates the impact of new growth in Western Riverside County. Each of WRCOG's member jurisdictions participates in the Program through an adopted ordinance, collects fees from new development, and remits the fees to WRCOG. WRCOG, as administrator of the TUMF Program, allocates TUMF to the Riverside County Transportation Commission (RCTC), groupings of jurisdictions – referred to as TUMF Zones – based on the amounts of fees collected in these groups, and the Riverside Transit Agency (RTA). Fees are used for planning, engineering, right-of-way acquisition, and construction of eligible TUMF facilities. Since the Program began in 2003, more than \$635 million in revenues have been collected, and nearly 85 projects have been completed. In all, TUMF will provide nearly \$4 billion in improvements to Western Riverside County.*

### **Priority Project(s) for the Pass Zone 5-Year Transportation Improvement Program (TIP)**

The 5-Year TIP cycle provides an overview of projects programmed by jurisdictions with the expectation of moving the projects forward. However, due to the lack of revenue in the Pass Zone to cover programmed projects, the Zone Committee will discuss project delivery.

Project delivery is the cornerstone of the TIP and prioritizing a zone project(s) will ensure that improvements to the TUMF Network will be made during the 5-Year TIP cycle.

The Pass Zone TAC will discuss each of the programmed projects with the goal of selecting a Zone priority project(s). Prioritizing a project(s) that is currently programmed on the 2016 Pass Zone 5-Year TIP will provide additional funding for the completion of the selected project(s) over the 5-Year TIP cycle. This will ensure that projects of significant importance to the Zone will progress and be completed with available TUMF funding.
